This MQA accredited program covers a wide range of taxation courses in direct and indirect tax. Out of the 8 papers required in the professional examination of Chartered Tax Institute of Malaysia (CTIM), 7 papers will be exempted upon completion of this program. Apart from CTIM, this program is also recognized by Lembaga Hasil Dalam Negeri (LHDN) and the Malaysian Association of Tax Accountants (MATA). The graduates therefore will have a wide range of job opening in private and public sector organizations such as LHDN, Royal Malaysian Custom Department (RMCD), multinational companies, accounting and audit firms and tax consulting firms. After gaining adequate work experience, graduates will be eligible to apply for tax agent license under section 153(3), Income Tax Act, 1967 that will entitle them to set up their own tax consulting firm.

ADMISSION REQUIREMENTS

STPM A pass in Sijil Tinggi Persekolahan Malaysia (STPM) with a minimum grade of C+ (Grade Point of 2.33) in any TWO (2) subjects; or

A LEVEL A pass at A-Level with any TWO (2) subjects; or

MATRICULATION / FOUNDATION A pass in Matriculation/Foundation qualification with a minimum CGPA of 2.50; or

STAM A Pass in Sijil Tinggi Agama Malaysia (STAM) with a minimum grade of Jayyid; or

UEC A pass in Unified Examination Certificate (UEC) with minimum of grade B in FIVE (5) subjects; or

DIPLOMA A Diploma (Level 4, MQF) in accounting or related fields with a minimum CGPA of 2.50; or

IB A pass in International Baccalaureate (IB) Diploma with minimum score of 30 points.

OTHERS Other equivalent qualifications recognised by MQA/Malaysian Government:

- Diploma Kolej Vokasional (DVM)
- Diploma Executive UM

APEL (Accreditation of (Prior Experiential Learning)

INTERNATIONAL IELTS Band 5.5 or TOEFL 550 or a minimum of Grade B2 (162) in First Cambridge English (FCE) or MUET (Band 3) or other equivalent English qualification recognised by MQA/ Malaysian Government.

**The validity period for TOEFL and IELTS is TWO (2) years from the date of the award.

ADDITIONAL REQUIREMENTS

Obtained Band 2 in Malaysian University English Test (MUET) AND a Credit in Mathematics and a Pass in English at SPM level or any equivalent qualification.
